25,000 South Africans call on Finance Minister Enoch Godongwana to reduce income tax

Pretoria, South Africa, 24 January 2023

The Chartered Institute for Business Accountants, a South African based professional body for accountants, created a petition with well-known activist platform Change.org, to call on Finance Minister Enoch Godongwana to reduce income tax for South Africans.

24,604 South Africans have <u>so far</u> signed the petition calling for the government <u>to plug the tax</u> gap with cash from tourists and not increase income tax.

"It's not fair that 2.5 million people are being asked to bear the brunt of the <u>income</u> tax burden," said CIBA CEO, Nicolaas van Wyk. "South Africans are compliant tax payers but we need help <u>from government</u>. It's time <u>for government</u> to <u>fully appreciate the burden that the income tax burden is placing on this small tax base and to work to fix this issue.</u>

"The response to this petition has been overwhelming, and we are grateful for the support that we have received from all corners of the country," said van Wyk.

SAIBA is now calling on the Minister of Finance to respond to the petition in the national budget speech of 2023. The Minister is also a tax payer and is sharing the pain with all of us.
